- 4.1 The company is responsible for providing information, instruction, training and supervision in regard to health and safety of its employees in accordance with Occupational Safety and Health Act of 1997;
- 4.2 Management is responsible for providing all necessary resources for the fulfillment of this policy;
- 4.3 Managers are accountable for the Health and Safety of people in their departments;
- 4.4 Managers lead by example by committing to the HSEQ principles and requirements of this organization;
- 4.5 Employees are obliged to act in a manner that does not endanger their life and the life of others around them. Safety is a basic pre-requisite for continued employment at NOCMA:

- 4.7We shall continuously protect people, property and the environment by following best operating practices in our day to day operations.

## **DRIVER SAFETY POLICY**

#### 1. Introduction

NOCMA values the lives of employees, business partners and neighboring communities. Our goal is to conduct our business in a safe, secure and eco conscious manner. This policy is in place to promote safe driving behaviour amongst our employees and business partners for their safety and the safety of other road users.

2. Responsibilities of the driver

Every driver of NOCMA owned, rented, leased or private vehicle used on company business shall:

- 2.1 Be in possession of a valid driving licence for the type of vehicle;
- 2.2Be in possession of a valid Defensive Driving Certificate;
- 2.3At all times, operate the vehicle in accordance to the requirements of the Road Traffic Act of Malawi and/or other applicable Acts if driving outside the country;
- 2.4Ensure that the vehicle is in good working condition before commencing any journey;
- 2.5Ensure that all licences and permits are available and valid;
- 2.6Not drive under the influence of alcohol or drugs;
- 2.70nly drive if physically, psychologically and medically fit;
- 2.8Ensure that seat belt is worn, at all times, by all occupants of the vehicle before the vehicle is in motion;
- 2.9Not use any communication device, unless the vehicle is safely and legally parked;
- 2.10 Not operate the vehicle at night if travelling outside a city or town. Authorized hours of driving shall be from 6am to 6pm;
- 2.11 Take a minimum of 15minutes health break after 2.5hours of continuous driving; and
- 2.12 At all times comply with NOCMA's transport policy requirements

# 3. Responsibilities of the company

National Oil Company of Malawi shall:

- 3.1 Ensure that vehicles are issued to personnel with valid driving licence;
- 3.2Ensure that the vehicle is repaired and maintained according to the requirements of the manufacturer and any other local requirements; and
- 3.30ffer training and/or instruction required for the fulfilment of this policy.
